



## **RE STELVIO MAPEI – 40th edition SUNDAY July 13rd, 2025**

### **REGULATIONS**

A.S.D. UNIONE SPORTIVA BORMIESE affiliated with the Italian Cycling Federation with company code 02Y3602 and the Italian Athletic Federation with company code SO532 organizes on 13/07/2025 the 40° edition of the cycling event called RE STELVIO MAPEI open to FCI cycle-amateurs and sport promotion entities and the running street race FIDAL.

The following events are also scheduled: a noncompetitive cycling event, an event open to E-BIKE and a running event open to everyone. The event takes place on the Bormio-Passo dello Stelvio route, with crossing of the towns of Bormio (SO) and Valdidentro (SO).

#### **1 ) PARTICIPATION**

The following categories are admitted to the event:

FCI male cyclo-amateurs from JUNIOR SPORT to MASTER 8 (aged 17 and older from 2008)

FCI female cyclo-amateurs from JUNIOR SPORT to MASTER 8 (aged 17 and older from 2008)

FIDAL Senior, Promesse and Master.

On the side of the amateur cycling event and the FIDAL running event a noncompetitive cycling event open to all cyclo tourists (aged 13 and older from 2012) and a noncompetitive running event open to everyone are also scheduled.

Participation is open to all FCI members and/or FCI-affiliated sport promotion Entities of both sexes and foreigners holding a UCI-recognized card.

It is MANDATORY for all enrolled participants to the event to wear a HELMET and respect and abide by rules of the Highway Code.

All who belong to the competitive categories (professionals, Elites, Under 23, Juniores – male and female) can – unless authorized by the company-group they belong to, who need to show the authorization to the Jury – participate in the cyclo-amateur events only as promoters, without being included in the race/event rankings. The participation of competitive athletes (professionals, Elites, Under 23) is accepted, only upon invitation and in possession of a written authorization from the Company they belong to, that has to be shown to the Jury. Competitive athletes must not be included neither in the absolute rankings and the categories rankings nor falsify the event in any way.

Former athletes can participate in the amateur competitive event only in accordance with the implementing amateur rules 2025.

We remind that the health certificate provided must necessarily be valid at the date of the event.

The organization committee reserves the right to cancel registrations that lack the required documents and information.

#### **2) ENROLLMENTS**

Applications must be entered on the online platform

#### **3) ENROLLMENT FEE**

The set enrollment fee is of € 50,00 (up to 31/05/2025) and of € 60,00 (from 01/06/2025 to 10/07/2025) and it includes:

- WINNING TIME CRONOMETRAGE SYSTEM with chip
- RACE PACK including CELEBRATORY JERSEY RE STELVIO MAPEI 2025
- RESOURCES N. 4 refreshments on the route (TRE BARACCHE, CENTRALE A2A, 3rd CANTONIERA, 4th CANTONIERA) and N. 1 refreshment party in Bormio

- MECHANICAL ASSISTANCE
- MEDICAL ASSISTANCE WITH AMBULANCES

**(N.B. No plastic bottles are previewed at the refreshment points, but the drinks will be distributed in glasses made of compostable materials.)**

#### **4) ENROLLMENT TRANSFER AND CANCELLATION**

The organization committee will accept the transfer of an already completed registration, it is necessary to communicate the new name and provide the related documents before 05/07/2025 and complete the payment of an additional € 10,00 as office fees.

Should a participant not be able to participate in the Re Stelvio Mapei 2025, the entry will NOT be held valid for the 2026 edition and the enrollment fee paid will NOT be refunded.

#### **5) RACE PACKET AND NUMBER PICKUP**

The race packet and bib number pickup will be on the following days and times:

SATURDAY JULY 12nd from 10,00 to 20,00

SUNDAY JULY 13rd from 6,30 to 8,00

The front number must be mandatorily placed in front on the handlebars, in an extended and clearly visible way.

It is forbidden to fold, cut and wrap the front number to the frame, concealing numbers, inscriptions or symbols.

Failure to use or incorrect use of the chip will result in the non-inclusion in the rankings and the non-attribution of the time achieved. The bib number and the chip are strictly personal and not transferable to third parties, under penalty of immediate disqualification.

The participants to the running events must place the number on the front of the jersey with safety pins.

#### **6) MEETING, GRID COMPOSITION AND CLOTHING BAG DROPPING POINT**

To facilitate the starting and allow a neat start of the race 5 GRIDS are provided:

- PEDAL ASSISTED E-BIKE
- 21 KM RUNNING RACE
- RUNNING EVENT OPEN TO ALL, FEMALE CYCLISTS (ONLY members) and 1° AMATEUR MEMBER BIKERS
- AMATEUR MEMBER CYCLISTS
- CYCLO TOURISTS and NON-MEMBERS

No one will be allowed to enter a grid different from the one they have been assigned to.

We ask to abide by utmost sportsmanship.

All the participants, at the time of the number pickup, will be given a bag to store clothing, which the organization will take care of bringing to the top of the Stelvio. Runners must deliver the clothing bags to the trucks for the transport to the Stelvio Pass before 8.00 am. Cyclists must deliver them by 8.30 am. Grid access will be granted to PEDAL ASSISTED E-BIKE and RUNNERS from 8.00 to 8.30 am, to CYCLISTS (no E-BIKE) from 8.00 to 9.15 am, latecomers will start from the last grid.

#### **7) START**

Starting times for the participants are the following:

1. 8.50 am NON-COMPETITIVE E-BIKE RIDE
2. 9.00 am 21 KM RUNNING RACE
3. 9.05 am RUNNING EVENT OPEN TO ALL
4. 9.15 am COMPETITIVE WOMEN'S CYCLE RACE
5. 9.30 am COMPETITIVE CYCLE RACE
6. FOLLOWS "ALDO SASSI" MEMORIAL BIKE RIDE



## **8) ROUTE**

The events will be carried out on the usual route of 21 km from Bormio to the Stelvio Pass. From Bagni Vecchi to the Stelvio Pass the road will be closed to automotive traffic from 8.45 am to 2 pm.

## **9) SUPPORT**

No type of vehicles is allowed to accompany participants. All kinds of accompaniment, relatives, friends and accompanying people are strictly forbidden; laws enforcement officers and the staff will ensure this rule will be rigorously abided. UNAUTHORISED cars or motorcycles can be a threat to everyone's safety.

## **10) SIGNS AND BANNERS**

Any kinds of information, kilometers, dangers, photo area, refreshments, mechanical assistance, will be pointed out by signs placed on the side of the road.

## **11) RESPECT**

The Organizing Committee responsible for the management of the entire organization of the event relies on numerous volunteers (race pack collection, crossing staff, refreshment staff, mechanical assistance etc.). Their presence is a precious asset; therefore, all participants are asked to respect our staff. Respect and esteem can only benefit everyone.

## **12) TIME LIMIT**

1.30 PM IS THE ARRIVAL TIME LIMIT FOR EVERYONE.

## **13) MEDICAL ASSISTANCE**

4 mobile ambulances are stationed on the route and one at the finish, with doctors and nurses.

## **14) MECHANICAL ASSISTANCE**

The assistance provided by the mechanical service will be of primary necessity and not of adjustments or replacements of parts involving painstaking work. In the case of part replacements, the cost will be borne by individual competitors.

As of implementing regulations of the cycle tourism industry and national amateurs FCI, it is strictly forbidden to receive mechanical assistance from private resources and other participants.

In case of necessity, participants must resort to the assistance provided by the organization or autonomously take care of reparations. Any kind of work on the bicycles must be autonomously carried out by participants, who should bring their own repair kit. Under no circumstances are cars or motorcycles allowed to accompany the participants, private or of companies. The organizers of the event are obliged to verify, with the help of the event Judges the abidance by this rule and will be held responsible of any violations. Every participant who will make use of assistance will be disqualified. Broom service is provided.

## **15) BEHAVIOUR ON ROUTES**

During the carrying out of the event the absolute abidance by the Highway Code of all participants applies, with special attention on the descent from the Stelvio Pass to Bormio.

## **16) INSURANCE AND DAILY MEMBERSHIP**

Each card-carrying participant is insured with his/ her own card.

For those who are not in possession of an annual FCI card or Coni approved entities card, it is possible to sign up for a daily FCI card at the price of € 10,00; the membership regularizes the athlete's position from an insurance point of view.

## **17) CLASSIFICATIONS**

The award ceremony will take place at the sport center of Bormio at 4.00 pm.

Individual awards are provided. The top three absolute male and female positions and female of the competitive cycling event, the top 10 absolute positions of the 21 km FIDAL event, the top 5 women of the 21 km FIDAL event, top 3 positions of the running event open to everyone, the top 3 positions of the cycle rally and the winner of all the categories of the competitive events will be awarded on stage. The awards from the 5th to the 2nd positions of every category of the competitive cycling and the 21 km running race can be collected at the Bar Pentagono.

At the award ceremony of the FIDAL 21 km running race the awards are not cumulative. The awards not collected at the award ceremony will neither be mailed or delivered at home.

### **18) EVENT CANCELLATION OR ROUTE CHANGES**

If, due to force majeure or any other cause not attributable to the organization, the event does not take place, the participation fee will neither be refunded nor recognized for the following year. Due to force majeure the Organizer reserves the right – even during the event - to make changes to the route.

### **19) VIDEOS AND PHOTOS**

### **20) VARIATIONS**

The organization reserves the right to make changes to these regulations at any time at its sole discretion. The websites <https://restelvio.mapei.com/2025/en/> and <http://www.usbormiese.com> are the sites of the event and the tools in which to find information and official announcements.

### **21) MISCELLANEOUS**

For matters not covered in these regulations and in the directions WHAT YOU NEED TO KNOW TO... the general rules laid down in the F.C.I. regulations for amateur and cyclotourist activities apply.

Unione Sportiva Bormiese disclaims all liability for itself and its employees, for accidents or damage to persons and/or property, which may occur before, during and after the event. The Organizer reserves the right to exclude athletes for improper conduct before, during and after the event.

For competitors who throw garbage and objects of any kind outside of the designated spaces located near the refreshment stations, will be disqualified and will not be able to participate in the event the following year. It should be noted that for a correct and safe conduct of the competition, no vehicles will be allowed to follow and the data of the vehicles that may follow the competitors abusively and pass through the space interdicted to normal traffic, will be detected by the inspectors of the organization and handed over to the Jury and the competent Police body, for possible measures both sporting and traffic violations.

### **22) SIGNATURE AND PRIVACY**

By sending the online registration form, the contestant declares that he/she knows and accepts the regulations of the event and is in possession of a valid medical certificate (certificate of sports medical fitness for competitive sport activity for the events of 21 KM RUNNING RACE and RE STELVIO CYCLING and Certificate of good health for the RUNNING EVENT OPEN TO ALL, "ALDO SASSI" MEMORIAL BIKE RIDE and NON-COMPETITIVE E-BIKE RIDE) to participate in the event, in accordance with the DM 18/02/1982 e 28/02/1983 and being 18 of age – if younger than 18 – to be in possession of a written authorization to participate signed by who retains the parental care.

Participants of the non-competitive events (RUNNING EVENT OPEN TO ALL, "ALDO SASSI" MEMORIAL BIKE RIDE and NON-COMPETITIVE E-BIKE RIDE) younger than 18 must use the authorization form, sign it and hand it in to whom authorizes to the participation when collecting the race package; those who fail to hand in the authorization, will not be able to participate in the non-competitive events. The participant also expressly claims under his/her own liability to have said the truth (art. 2 law 4/1/1968 n. 15 as amended by the art. 3 paragraph 10 law 15/5/1997 n. 127) regarding the information above indicated, and to exempt the Organizer of the event and all the



sponsors of the event of any liability, both penal and civil, from damages to people and/or property caused because of his/her participation in the event.

The Organization disclaims all liability for potential incidents of all natures, which may involve participants before, during and after the event.
